Biography:

Teresa Lloyd Braga is a full professor at Universidade Católica Portuguesa (UCP). She holds a Ph.D. in Economics from UCP (Lisbon) and she is a researcher at CUBE, the Business and Economics Research Unit of the Católica Lisbon School of Business and Economics. Her research work, focusing mainly on Expectations-driven Business Cycles, Non Linear Dynamics and the role of Market Imperfections on General Equilibrium Macro Models (closed and open economies), has been presented in several international conferences and published in scientific journals, as, for instance, Journal of Economic Theory, Journal of International Economics, Economic Theory.

Course overview and objectives:

This course focuses on international trade theory and its applications. We discuss economic incentives for the existence of international trade and of factors' movement. We study the pattern of trade and the effects of trade and of trade policy instruments on relative prices, volume of trade, income distribution and economic welfare. Standard models are used to address these issues.

Students are supposed to get knowledge on how trade models work and the mechanisms they describe. They should also be able to choose the most suitable model to answer specific questions and to discuss issues related to international trade and factor movements.

Required background:

Students should have attended an intermediate microeconomics course

Grading:

Two compulsory exams: Mid-term exam (42.5%) and End-term exam (42.5%).

A <u>compulsory written group work</u> with oral presentation (10%)

Compulsory peer work group discussion (5%)

<u>Final Exam</u>: Compulsory for students whose average is between 8 and 9 (in a scale 0-20), and for students that attained an average mark higher or equal to 10 but with a very low mark (usually below 7) in one of the compulsory exams. Optional for final grade improvement: students do not fail but past grades are taken into account.

The passing final average is above or equal to 10.

Attendance to classes and active participation in the discussion of the topics lectured may also be taken into account.
