Course overview and objectives:

The objective of this course is to deepen the study of microeconomics, by exploring the way microeconomic theory approached the main questions related to consumer and firm behavior.

Course Content:

- 1. Consumer Choice (Duality, Welfare)
- 2. Firm Choice (Cost Minimization, Profit Maximization)
- 3. General Equilibrium and Social Welfare
- 5. Monopoly and Monopsony
- 6. Oligopolistic Markets (Incumbent Advantage, Entry deterrence, Market Power, Product Differentiation)

Required background:

Students should have attended the Microeconomics I course at Católica Lisbon.

Grading: Midterm: 50%, Endterm: 50%

If average is higher than 9.5 students will pass the course.

If average is higher than 7.5 students will be admitted to final exam.
