LEARNING OUTCOMES (KNOWLEDGE, SKILLS AND COMPETENCIES TO BE DEVELOPED BY STUDENTS)

Objetivos:

A disciplina visa oferecer uma panorâmica geral da história do século XX português.

O principal objetivo da lecionação será apresentar um conhecimento factual e cronológico da evolução portuguesa ao longo do século XX, incluindo, na introdução, o tema da crise e

falência da Monarquia Constitucional e, na conclusão, uma reflexão sobre os problemas e perspetivas nacionais atuais à luz do passado mais recente.

A disciplina privilegiará tópicos sequenciais, nas suas dinâmicas políticas, institucionais, culturais ou sociais/económicas, procurando estabelecer aproximações comparativas com a história europeia e global do período.

Competências:

No final da disciplina, os alunos deverão ser capazes de:

Identificar as datas, factos e figuras mais relevantes da história contemporânea de Portugal, e situá-los tanto no contexto nacional como no contexto internacional;

Identificar e sintetizar as principais interpretações historiográficas a propósito de grandes temas ou conceitos da contemporaneidade portuguesa;

Desenvolver uma reflexão crítica sobre os fenómenos históricos, compreendendo o seu impacto nos discursos contemporâneos e na identidade nacional;

Explorar e assimilar informação através da leitura de bibliografia selecionada e da interpretação de fontes visuais de conhecimento.

Objectives:

This course aims to provide an overview of the history of Twentieth-Century Portugal.

The main teaching goal will be the presentation of a fact-based and chronologically grounded knowledge on the evolution of the Portuguese Twentieth-Century, encompassing a longer time-span that begins with an introductory survey about the demise of the Constitutional Monarchy, and ends with an open reflection about the problems and perspectives of present-day Portugal in light of its recent past.

The course shall privilege sequential topical issues, and their respective political, institutional, cultural or social/economic dynamics, seeking to establish comparative approaches with the wider European and global history.

Competences:

At the end of the course, students should be able to:

Identify the most relevant dates, events and figures in contemporary Portuguese history and relate them with both national and international contexts;

Identify and synthesize the main historiographic interpretations about large themes and key concepts of Portuguese contemporary times;

Develop a critically based reflection on historical phenomena, assessing their impact on contemporary discourses and national identity;

Explore and assimilate information through the reading of selected bibliography and the interpretation of visual knowledge sources.

7. METODOLOGIA DE ENSINO (AVALIAÇÃO INCLUÍDA)

TEACHING METHODOLOGY (INCLUDING ASSESSMENT)

O ensino é de cariz teórico-prático, combinando a exposição do docente na aula com a análise de *powerpoints* de imagens e de documentação selecionada, chamando os alunos a um envolvimento regular no debate coletivo.

A avaliação baseia-se nos seguintes elementos:

- 1.º Teste Escrito (45%).
- 2.º Teste Escrito (45%).
- Assiduidade e qualidade da participação individual nas aulas, demonstrativa da realização de leituras e do interesse no comentário de materiais utilizados nas mesmas e no debate com os colegas e o professor (10%).

Qualquer evidência de plágio será punida com a atribuição de zero ao elemento de avaliação que tenha utilizado indevidamente textos de terceiros.

The teaching methodology is a theoretical-practical one, combining the presentation of contents by the teacher with the analysis of image *powerpoints* or selected documentation in class, hence calling the students to engage into a regular collective debate.

Evaluation is based on the following elements:

- 1st Written Test (45%).
- 2nd Written Test (45%).
- Class attendance and relevance of student's individual participation, evincing knowledge of bibliography, and active interest in commenting documentation shown in class or in debating questions with the colleagues and the teacher (10%).

Any evidence of plagiarism shall be penalized with a mark of zero (0). Plagiarism is the improper use of a text and/or ideas that are not one's own.
